C20.120 - Apologies for absence were received from Cllrs Anderson, Cave, Jackson and Wilkinson.

C20.121 - Declarations of Interests and Grant of Dispensations

C20.122 - Exclusion of the press and public

It was RESOLVED that the terms of employment will be similar to those of the present clerk and based on the model contract and that if minor amendments are needed they can be agreed by the recruitment working group. Proposed by Cllr Hardingham, seconded by Cllr James, all in favour.

C20.124 Vacancies - To consider all applications and to co-opt up to 3 Councillors to fill vacancies in Long Ashton Ward.

Two applications had been received to join the PC. The clerk confirmed that both applicants were qualified to be Parish Cllrs and that Cllrs had received their letters of application.
