

## Footpaths Survey September 2020

**1. Introduction**

We ran an electronic survey for 10 days to 15th September 2020 in order to seek local views on footpaths, cycleways and bridleways in the parish of Long Ashton. The survey was advertised on the Parish Council Facebook page and along the main public rights of way in the parish.

**2. Results**

207 people responded to the survey. Given the limitations of time, access and publicity survey, this demonstrates a high level of active interest in the local Rights of Way. The results are:

**3. Initial comments**

The size and nature of the responses demonstrates that for many people, the local footpaths are an important and pleasurable part of village life, providing safe routes to school and work as well as for fitness and recreation.

People are using the full range of local paths, within the Parish Council area and beyond. However their are major concerns about road safety and safer crossings. People would also welcome better sign-posting, easier

access, rest points, information, safe routes to local amenities and the cutting back of vegetation. In addition there are some tensions between different users of Rights of Way with at least one person reporting an accident.

**4. Next steps**

The information will be used to:

1. Re-establish a Long Ashton Rights of Way Forum. In the current circumstances I am considering a quarterly on-line forum and regular 'Walk and Talk' events in small, socially distanced groups where we will discuss relevant issues as we walk and clear the paths.
2. Respond to the North Somerset Council Public Rights of Way Improvement Plan by 1st October 2020
3. Draft a Long Ashton Parish Council Rights of Way Improvement Plan in consultation with the local community
