# CHAIRMAN'S NEWSLETTER

The very sad news of the sudden death of Nick Shopland the Headmaster of Birdwell School has come as a great shock to us all in the village and our heartfelt condolences go to his family. The teachers and pupils will in due course pick themselves up and go forward with the challenges that the welcome expansion of the school will present.

It is largely due to the pressure of the local community that this expansion is now in prospect. The Parish Council have actively supported the School Crisis Group in their efforts by lobbying the North Somerset Executive and more recently discussing with officers the suitability of land owned by the Parish Council for the expansion.

North Somerset has finally decided that the A370 B3128 junction realignment will be made permanent. I believe that the decision is wrong, however we cannot win all our battles. We have won some alterations to the original plan. The ingoing lanes of the bypass are to be widened so that buses in particular will not intrude into the outside ingoing lane. We have an undertaking that the new alignment will, as is the case currently, enable one to angle the car such that one can see traffic on the A370 in the wing mirror thereby saving ones neck peering over ones shoulder. It is the misjudgement of speed of vehicles on the A370 that is the problem, and whilst we are pleased to see the speed calming signs we have made it clear that more needs to be done in that regard before the continuing minor shunts are prevented.

I trust that there is no one unaware of the fact that our village is being threatened from all quarters by planning applications for large developments. We have done our best to keep everyone informed. This Council has for the last two years set aside funds to enable us to obtain professional advice when we feel it is appropriate, and we have budgeted to do the same this next year. Planning consultants have been appointed who have already proved their worth.

The Government's Regional Spatial Strategy has stalled further with the sustainability study not expected to be completed until March at the earliest. Any development in the Green belt is dependent on the RSS being approved. I believe that the Government may be reluctant to do this so near a General Election, bearing in mind the substantial cross party opposition to it. North Somerset's draft Core Strategy, whilst acknowledging the possibility of the South West Bristol urban expansion, 9,000 houses, does not include it, which is good news and I believe is due in no small part to the efforts of our Joint Parishes Group. We have been working very hard to influence, mitigate, persuade, cajole and frustrate this prospective development which two years ago was seen as a foregone conclusion.

The Link Road, the red route, is seen by Bristol as the answer to the regeneration of South Bristol and finds favour with North Somerset. We are concerned that it will further add to the congestion of the Cumberland Basin system and Plimsol Bridge.

### *Chairman's Newsletter continued ....*

It is my belief that the next Government will, given the current national debt, be unable to provide the level of funding required for many years.

The University application is now registered and we all have the opportunity to comment upon it and I encourage you to do so. It is again dependant upon the RSS gaining approval. This application is as big a threat to Long Ashton as Land Trust proposal and of course takes in valuable grade 1 and 2 farming land. It is vital in my view that we retain the ability to grow our own food in this country and we must not lose valuable land such as this to concrete, to do so would be criminal.

The Stadium application continues to give cause for concern. The application is for a commercial enterprise, which includes the proposed new home for Bristol City Football Club and it is that aspect that brings with it the emotional element. The use of the Stadium, if built, will need to be maximised and will include numerous non-sporting events the year round many of which will impact on our village. Fundamentally there is not suitable access for a Stadium of the size proposed, and this will create serious ongoing problems with volumes of traffic and parking issues should it go ahead.

Long Ashton already suffers from parking problems during home matches. The police currently place bollards at the Bristol end of the village in order to prevent a blockage. Those making the proposal make light of it but then they wouldn't they.

It is predicted that the average gate for the proposed stadium will be 23,800, with 80% arriving by car of which 26% will be drivers. This equates to 5,000 vehicles seeking a parking space, and 6,000 with a full gate. The stadium Company are providing 1,000 parking spaces of which approximately 350 will be available for the public. They could provide a further 1,000 spaces but choose not to do so, which clearly demonstrates their callous attitude to the local Community both in Long Ashton and Ashton Vale. We should be grateful for the support that North Somerset Councillors have given us so far.

Many will be aware that a local resident has been jailed for 5½ years for burglary. We must thank the Police for their work in fighting against criminal activity in our village, much of which we are unaware. May I remind you of the number to ring if you see anything suspicious or you suffer from a break in or attempted break in or witness nuisance or unsocial behaviour - **0845 456 7000**

I make no apology for planning matters taking up the bulk of my report, for it is they that take up much of my time currently.

Whilst it is still very cold, as I write, we must all be looking forward to the longer days, already apparent, and warmer temperatures in prospect.

# PLANNING

Planning applications and proposals from developers are continuing to arrive! The most up-to-date news is as follows:-

The land to the east of Weston Road, Failand where mixed development, including 500 dwellings, is proposed is to be the subject of a public inquiry in March. The applicant has appealed against non-determination by North Somerset although the authority has since published their reasons for refusal. The inquiry is scheduled to commence on Tuesday 9th March and will last for at least six days. It is being held here in Long Ashton in the Pavilion, which is on the Village Hall site, and residents will be able to attend.

North Somerset Council is currently considering the application for a new football stadium at Ashton Vale and is looking particularly at the access and parking arrangements which will have an effect on residents in North Somerset and the Park and Ride site.

The application, made by Land Trust, which includes 9,500 homes in the area is being assessed by North Somerset Officers and will be considered by the relevant committee in the next few months.

The University of Bristol has just submitted their plans for a mixed use development on land south of the railway line and to the east of Wild Country Lane. This includes 1,000 dwellings, employment, recreation, a Primary School and site for a railway station. These plans will be commented on by the Parish Council Planning Committee at the earliest opportunity.

All the above applications are on land which lies within the Green Belt and North Somerset have said they have no plans to alter their Green Belt boundaries and are firmly opposed to the proposed urban extension.

We understand Officers in North Somerset and Bristol are preparing a bid to Government for the construction of the South Bristol Link Road although there is a good deal of opposition to the indicated route.

The Draft Regional Spatial Strategy (RSS) has still not been approved by the Secretary of State so North Somerset decided to produce its own Core Strategy planning document for consultation. This has now been published and is part of the planning strategy for the whole of North Somerset, up to 2026, and sets out the vision for managing change in our area.

As a result of additional drainage works and maintenance to the football pitch at the Community Centre during the summer, playing conditions for Long Ashton Football Club have been greatly improved.

Additional barriers have also been erected by the football club around the periphery of the pitch to help with spectators on match days and to comply with league requirements.

Unfortunately, whilst the drainage of the pitch is now much better, the exceptional rainfall during recent months has resulted in a large volume of water run-off from the hillside above the Recreation Ground flowing across the pitch and channelling down Keeds Lane towards the main road.

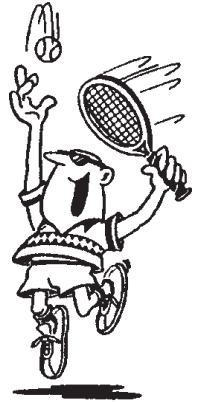

The Parish Council has learned that to deal with this run off and to alleviate the problems encountered in Rayens Cross Road, North Somerset Council are aiming to place a grid across the Keeds Lane/Rayens Cross Road junction and install a new pipe beneath the footpath down the lane to join into the drainage system on Weston Road.

# ANY OFFERS?

My Grandmother was Elizabeth Jane Offer, or at least she said she was when she married my Grandfather, Samuel Henry Dangerfield in Long Ashton Church on 30th August 1902. But I don't think that was her real name. I can't find a birth certificate for her, and no father's name is quoted on the marriage certificate.

There *was* a family of Offers living in Long Ashton at the time, and on the night of the 1901 census, my grandfather was staying at Clerkencombe Lodge on the Long Ashton Estate, with Mary Offer, widow of Charles Offer, together with Mary's son Edward and Jennie Davis, a visitor.

I checked back through the censuses, and found in 1881 Charles and Mary Ann Offer with a daughter Eliza Jane, a son Edward and Elizabeth J. Davis, aged 12, a boarder. In 1881, Charles and Mary Ann, living at Providence with their son Henry, daughter Eliza Jane, son Edward and Elizabeth J. Davis, a boarder.

Gran always said she was found in a shoe box on the steps of Long Ashton Church, and I am wondering if this Elizabeth J. Davis / Jennie Davis is Elizabeth Jane Offer - my Grandfather always called her Jennie. Perhaps she was a foundling and these good people took her in.

Perhaps she didn't know her name was Davis. I've tried the records of Long Ashton School, but they don't survive for the time she would have been a pupil there. I've tried the baptism records for the Church and Somerset Record Office for Birth Certificates for either name, all to no avail.

Does anyone know anything about the Offers? Are there any descendants living locally or anyone who remembers hearing about them?

Any light anyone can shed on this would be much appreciated.

# HANDS OFF LONG ASHTON

We originally started as the Long Ashton section of the Alliance Against the South Bristol Ring Road but then all the development proposals inspired by the Regional Spatial Strategy came along. We decided that we had to campaign against all these proposals which would be so damaging for Long Ashton as well as the ring road, (now called the South Bristol Link).

Looking back over the last year the group has actively recruited members, distributed leaflets, organised a petition to parliament, held public meetings, submitted objections to planning committees, held social events, informed the media, been on TV and, most importantly, the supporters have been active in writing their own letters and emails. We are part of the Save Our Green Spaces umbrella movement which facilitates contacts between the groups such as ours and helped co-ordinate a campaign against the RSS over the entire South West of England. HOLA is now established and has been quoted in several official documents, (one recently transposed our initials to become HALO!). Our existence is acknowledged and our opinions are being heard.

Much has happened during the last year. At the outset we were told that opposition to the RSS was useless, it would all happen irrespective of local opinion. Well, that has changed and North Somerset is now strongly against the urban extensions and says so in the recently issued draft core strategy, which is set to become North Somerset policy. The RSS itself is now in limbo. The government was forced to undertake a review following a legal challenge to another RSS. We hope that the imminence of the general election and the stated strong opposition of both Bristol and North Somerset will see this plan cancelled. This could save the village from the unwanted developments in the green belt.

On the negative side, the proposals for the Bristol Stadium were approved in principle by BCC, although the plans for the access in North Somerset were refused. The story on that is not over (at the time of writing). HOLA are campaigning for a public enquiry in the hope that the flimsy basis for building in the green belt can be exposed. The South Bristol Link looks likely to be approved by the West of England partnership who would then apply to the Department for Transport for funding. Even if the application is made there is still some way to go before the money is provided, which may not happen if there are big spending cuts.

We can never know how much the protests from individuals and the various groups have influenced the decision makers. However, I feel that the councillors who made the decision to refuse the stadium access proposals, contrary to NS officers' recommendations, must have heard the voices being raised in opposition. There is a lot at stake for the village and everyone should feel that they have done as much as they could.

Campaigns take a lot of work and often this is done by just a few. I think the position that HOLA is in now shows that our campaign is worthwhile and can achieve results. So what can you do? First please sign up as a supporter, (email me chair@handsofflongashton.org.uk, I have been given several e-mails that don't work, so if you have signed up and are not getting anything from me you are probably one of those, so email me). Even if you just "spread the word", this can change opinions. Better, respond to the requests to send letters and emails to the decision makers, we know that they are influenced if a large number of people say the same thing. Finally, if you have some time to get more involved please let me know. There are more things we could be doing, but we need more Hands On in Long Ashton, to keep other Hands Off Long Ashton, Think about it, can you do a bit more to save our village?

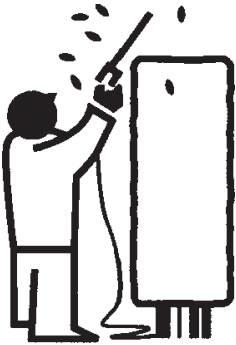
